Assembly Minutes

Meeting was called to order by Delegate Cesar at 9:05AM with a moment of silence, followed by the Serenity Prayer. Delegate gave his report (see below) and had open mic time for people to discuss their PRAASA experiences. At 10AM the ASC broke into Standing Committee groups. Our Chairwoman Sharon called the ASC to order at 12:01PM.

Readings: Declaration of Unity read by Megan in English/Juan in Spanish. The Statement of Purpose and Membership read by Mike in English/Rosendo in Spanish.

Introductions: Past Delegates, New DCMCs/Alt. DCMCs, New DCMs/Alt. DCMs, New GSRs and Alt. GSRs, Guests, and Area Officers.

Approval of minutes from the February ASC. Motion made by Dawn, seconded by Julie and were passed without any amendments.

Officers/Directors Reports (following reports are written reports):

Delegate Cesar: My name is Cesar and I am an alcoholic, and it is my honor and privilege to serve as Panel 64 Area 09 Delegate. My sobriety date is Jan, 6 1996 and my home group is Grupo Libertad in Santa Ana, CA. WELCOME ALL GSRs attending here today!! Since the last ASC, I have attended District 5 on 2/13, participated in a Group in Santa Ana on 2/14, on 2/15 I attended the 4 Area DMC Sharing Session in Upland, the Area Officers Meeting on 2/16, a 2/18 meeting with Joe our Alternate Delegate, participated in a Group in Indio, on 2/23 attended the Intradistrict meeting (where all the Spanish speaking Districts meet), participated at District 22 on 2/25, attended District 23 along with all Area Officers on 2/28, attended an ad hoc committee at the Archives for the background summaries on 3/1, on 3/2 attended the Special Meeting, then March 7, 8 & 9 I attended my 13th PRAASA, on 3/14 visited a group with District 25 in Fontana and am attending here today. This PRAASA had 1830 registered members in attendance. My experience was that I got to meet all the Pacific Regional Delegates. The Area 58 Delegate was not able to attend, but the Alternate Delegate was there to represent his Area and did a terrific job. All the Delegates met for first time on Friday 11am for lunch. When PRAASA officially opened, I had the opportunity to give a 2 minute Area highlights. On Friday I participated with my topic "The Membership Survey - What Goes Into it, and How is it Useful?". After that, our Friday round table meeting that night went until 11pm. On Sat I attended the Delegate's luncheon at noon, and then our last round table. At

6pm I attended the Banquet with 2 speakers. Sunday I was at the "Ask It Basket" questions, and then the event was officially adjourned by the Area 08 Delegate Dean B.

If we need more time to contract GSO to change and existing group status then we have to deal with the GSO Registration Desk directly.. We are still work in progress buy I will soon have updated information for all the districts. If you have new group forms or new GSR forms please come see me. Thanks you for allowing me to serve.

Treasurer Rozanne: My name is Rozanne, I am an alcoholic and I honored to serve as your Area 09 Treasurer. I attended the 4 Area DCM Sharing Session, PRAASA, Area Board Meeting, Area Meeting and the Special Meeting.

I attended the 4 Area DCM Sharing Session on February 15th. There were 125 people in attendance and Area 09 had the most participants - 43 people. There were a lot of new DCMs who had the opportunity to hear the experience of the many past DCMs. It was a great success. The final transcriptions of the notes are almost complete. I am waiting for one more. I'll get it translated into Spanish and send it out to each Area's liaison. Next year, we are the hosts, and I believe that our new Liaisons (John W and Paco) will do a great job. I will be happy to make myself available to assist.

March 7-9th I attended PRAASA in San Diego. It was a great experience; I attended all the Panels as well as the Treasurer Workshop. There were a lot of people who were new to their treasury positions and many were using QuickBooks. The best suggestion I got was to put the budget on an excel spreadsheet. It really worked well, I might add! I plan to review the other suggestions to see which would work best for us. It was a really good group with a lot of good ideas.

As for the budget, we currently have: \$ 5709.44 in the checking account

Area 9 will be hosting this next year and I have appointed John W. from District 19 and Paco G. to be our Co-Chairs for the sharing session. This years event was very well organized and I know that they will be showing the way for our Area to host in 2015. I also attended District 23 with most of the board on February 28, chaired my 2nd Board Meeting (it was only four hours this time) and attended the Special Meeting and PRAASA.

As a result of the Special Meeting, I received several Ad Hoc committee requests and once I review these with the board will be letting you know whether we will be going forward with these requests. I also heard some discussion about Area 9 having an Area inventory. I took this idea to my Chair roundtables at PRAASA and asked them how they facilitate an Area inventory. I know our Area has had some sort of inventory in conjunction with the Servathon several years ago but nothing formal. What I found out as a result of this is that many Area's have it incorporated in their ByLaws/Guidelines and have it every several years. I also asked specifically how the Area inventory came to play for their respective Area's and all of them said that a proposal was brought forward and the Area voted whether they felt they needed an inventory or not. If the Area voted to have an Area inventory then, in some cases, the Chair appointed an ad hoc committee to create the format and/or questions. In all instances the entire Area participated in roundtables to do their inventory either on a separate day altogether or in place of business at their Area meeting. None of them had a select few doing the Area's inventory. I also found in some cases that their Area didn't feel the need for an inventory. Regardless of whether our Area decides to move forward with an inventory, I think it should be up to the Area and its groups to decide whether one is necessary.

I really enjoyed myself at PRAASA and was extremely pleased with our Chair roundtables and what resulted from those. I really learned a lot about how my respective Pacific Region Chairs handle difficult situations and got a lot of good advice. It's nice to know I'm not alone.

I also had the opportunity, thanks to a last minute invite, to get to know several new friends over dinner, one of which was the General Manager Phyllis. I also met Brouch H., a member of our National AA Website Committee. It's nice to know that AA is thinking of our digital future by forming such committees.

I look forward to hearing about everyone's experience about PRAASA later this afternoon and thank you all for letting me be of service.

Old Business:

- Special Needs Co-Chair – Chairwoman Sharon discussed that our Guidelines indicated that there is to be a Spanish language co-chair for Special Needs and currently we do not have one. Put word out to the Spanish community to encourage participation. No action taken.
- Archives Guidelines – Archivist Pete B discussed the changes proposed to the Archives Guidelines verbage (copies of proposed changes available to the ASC body in both English and Spanish). After much loving discussion by members, it was determined that the Spanish translation was not correct. Because of that, a motion was made by Ashly to table until June ASC due to these incorrect translations, seconded by Karen. Motion was approved with a majority and tabled accordingly.
- Term Limits Proposal – Alex brought forth the proposal that . After some loving discussion the question was called by Sandy, seconded by Steve but motion did not pass and discussion continued unabated. Motion did not pass.

New Business:

- Proposal brought forth by Hugo and seconded by Rich, a request to supply Area sound equipment and technical support for a non-Area event – the 11th Annual Inland Empire AA Congress in the City of

Barstow on April 18th, 2014. Mileage and lodging to be provided to Sound Tech to be paid for by the Inland Empire Congress. Chairwoman Sharon suspended the Guidelines with a majority vote to change this ASC into an Assembly for the purpose of voting; Rich made the motion to do so, which was seconded by Katherine. Discussion took place. Motion passed as presented.

Standing Committee Reports: (*Submitted In Writing*)

Archives Tony: At our regularly scheduled meeting on Sat 3/15, we had 10 members present. The Committee is working to develop a tri-fold brochure, will resurrect the Archives Workbook project started in 2012, and will complete the group history mural. The Committee revised the Guidelines that were presented at the March ASC. Plans are underway for our annual Open House to be held on May 31st. There will be District Archive Workshop for new Archivists on March 22nd at the Repository - located at 7111 Arlington Unit B, Riverside, CA 92503. We are open every Sat from 10 - 1 and by appointment. Our next meeting will be Sat 4/18 at 10am at the Repository and upcoming events also include the Open House on 5/31.

CEC Beka: Discussed packets and making a plan and areas to start; Doctors, clergy, etc. Again a possible plan to meet at Archives and are going to meet at Area meeting next month.

Communications Kris: No Report

CPC Maryka: We went over our invitations from GSO - the Nat'l Association of Drug Court Professionals, Anaheim, CA 5/28-5/30, 2014, the Association of Professional Chaplains National Conference starting 6/20/14. and the Consul General of Mexico Health Fair in October 2014. Went over the Conference Agenda Items. We read, discussed, and studied them at length along with the associated AA CPC literature. We came to a Committee conscience to pass along to our Delegate Cesar for the proposed changes to the 2 CPC pamphlets. For the "If You Are a Professional" pamphlet we voted unanimously to approve the recommended changes to the section 'referrals from Court and Treatment Facilities'. The Committee also unanimously voted against the proposed changes to the pamphlet "AA as a Resource for the Health Care Professional". Upcoming events include the NADCP Conference 5/28-5/30 and the Association of Professional Chaplains 6/20-6/21.

CPC Spanish Juan J: No Report

Convention Liaison Marilyn: Committee members Dennis P, Kelly Y, Joe B, Patti P, BarbaraDee, Hugo V, Catherine C and Marilyn P all attended PRAASA this past weekend - good turn-out, guys! We are gearing up for our coming conventions, the first of which is Orange County, followed by South Bay. Registrations and some reservations have been made and paid for. I've called ahead to the first few conventions to be assured that we have tables secured, and we do. At todays meeting with, 3 members present, briefly discussed who will be attending which conventions. The pending events are the Orange County Convention 4/18 - 4/20 and the South Bay Roundup 5/23 - 5/25.

Convention Liaison Spanish Hugo: No Report

Corrections Steve: We met and discussed the verbiage of the 3 revised pamphlets: 1) AA in Your Community, 2) If You Are A Professional, and 3) Members of the Clergy Ask About AA. The questions we had were whether or not we want to stay consistent with our wording/message on "what AA does NOT do" between the pamphlets. We decided that we would like our wording to stay consistent but our Committee votes for NO revision based on the fact we don't have enough information regarding funds and costs of this project. We want info on financial impact behind any changes.

DCM School Jim: We discussed group visitations and what occurred at them. We found solutions to problems in visiting groups. We shared about the tools we use to help with group visitations. The DCM School is an ongoing learning experience, not a one-time event. We cover new ground each session. The goal of the DCM School is to have each member gain a working knowledge of all our principals, and how to apply them to solve group issues. The May meeting will focus on working with GSRs.

DCM School Spanish Jose A: We began at 10:15am with 7 members present from Districts 20-25, Spanish speaking DCMs. We discussed the way in which they are working right now. In addition, we had some questions regarding strategies to better serve their Districts. I also made myself available to visit any District business meeting that we might be of help to.

Electronic Media Saturn: No Report

Finance-Rich W: 5 members present at this months meeting, along with 5 guests. We approved the minutes from the Feb meeting and got a report from the Treasurer. We are transitioning into QuickBooks and she prepared the reports in Excel. We will be communicating with the Standing Committees to update them on their budget status and maintain inventory of any equipment. We are working with the Treasurer to get the 2013 taxes prepared. We reviewed the Conference Agenda Items for Finance and discussed the costs of the Conference and why it is the important for the Area to contribute to help pay for some of the costs. We had several guests that asked great questions and contributed to the discussion. Our next meeting will be at 10AM at the Area Assembly 5/18.

Grapevine Ed: Our Chair is now registered with GSO in New York. Spoke 2/15 in Big Bear, and on 3/05 in Fontana. Have 14 people signed up for the September 2014 - there is a sign up sheet at all Area events for those who are interested. 5 people have signed up for Grapevine speaking engagements. Chair attended PRAASA including both round table GV discussions. Had articles published in both February and March 2014 issues of the GV. Please see GV display for subscription sheet, catalogs of available GV materials and other resources - numerous books, and materials regarding this years GV 70th Anniversary celebrations. Upcoming events include working with Elizabeth S from District #6 in July and an event at Archives in Sept with Pete B. The GV notes from PRAASA will be forwarded to the Area Secretary Barbara once typed.

GSR School English Gary: Discussed what a GSR is and does. Talked about the upcoming Pre-Conference Workshop. Also discussed the difference between an ASC and Assembly and the difference between a Delegate and a Trustee.

GSR School Spanish Amador: 22 in attendance – Opened with the Serenity Prayer. We spoke about PRAASA and we reviewed Concept III. Most of the attendees took part in the discussion. We closed the meeting at 11:15am with the Responsibility statement.

La Viña Victor: This is my first report as La Vina Chair. I attended PRAASA and went to the 2 different round tables that they had. I heard the opinion of the attendees and I think we all agree that the magazine is a service tool. Today I met with 6 members of the Spanish speaking Districts. We discussed supporting the 18th La Vina Anniversary in Las Vegas this year and to encourage more subscriptions in our own Area. District 20 reported that they now have 6 LVRs, District 22 has 2 and District 24 also has 2. Finally, I only received 3 CDs from the past chair of La Vina and some magazine covers. Therefore, I will have to buy materials in order to have a display available. The La Vina editor told me at PRAASA that she can only send the free material that is available at GSO. Thank you all for allowing me this experience as La Vina chair.

Literature English Bianca: We started with introductions and gathering of contact information. Much loving discussion of the Pre-Conference summary Item F – “the unofficial symbol (circle/triangle) being added to Conference Approved Literature” and Item G – “request to create a pamphlet for alcoholics with mental illness”. Discussion of the upcoming Area Literature Workshop, including roundtable discussion topics, speakers and flyers. Area Literature Workshop to be held on Saturday May 17th from 10am-2pm at the Archives at 711 Arlington Ave Unit B in Riverside, CA.

Literature Spanish Mauricio: We opened the meeting with 10 attendees at 10am. We discussed three out of six Conference Agenda topics. We are planning our Literature Workshop for May 17th from 10am-2pm at the Archives Location in Riverside. I will have flyers available very soon with info. Thank you for allowing me to serve.

Public Information Sandi: We went over the 'member survey' section of background info, as well as a website 'hits' chart. With 6 members in attendance, we had a Q & A from all attendees. We are cooperating with the Cooperation with the Professional Community Committee. Working on summarizing the PI portion (70 pages) of background material, as some of my groups in my District are concerned about the time frame and want input and I want them to know their input is valued. I just attended District #1's meeting on Thurs 3/13 and got to be of service for this ASC. My District just got our new location- District #18 (Costa Mesa/Irvine) and I got a new PI member there. Referred all to AA.org as it is without parallel! Currently working with CPC on upcoming drug court professionals and representing all of you and your groups. Looking forward to the workshop so we can have an informed Delegate at the Conference. Checking on status of a Vietnamese Big Book in the library. At the PRAASA PI roundtable we talked a lot about anonymity breaks at the level of TV. Much discussion about the PSAs - my idea is that the website address, AA.org, and the new slogan "we can

help" both need to be BIGGER. At PRAASA, my favorite part was the Trustee's slideshow ... but at least he knew to wear nylons with his high heels!

Public Information Spanish Martin: No Report

Registration: Pari had to resign, position now open.

Special Needs Jack: Still needed is a Spanish speaking Co-Chair. Working to form a Committee and make contact with the District Special Needs/Accessability Chairs. On a District level we are hoping to do something called 'mobile meetings'. Working to expand awareness of Special Needs and what falls into that category. Meeting with Bridging The Gap and Corrections.

Treatment Facilities Dawn: The Treatment Facilities Standing Committee ("Committee") met March 16, 2014, 10:00 a.m. at West High School. Six (6) Members were in attendance representing three (3) Districts. The meeting was called to order by the *Committee* Chair with the plural version of the Serenity Prayer. The Purpose and Scope of the *Committee* was read. The *Committee* discussed its goal of compiling and/or revising an Area 09 temporary sponsor list to be sorted by zip code. Questions posed were: Is there an existing temporary sponsor list?

- If so, where is this list?
- If so, how current?

The following action items were determined:

- Check the Area 09 website for past minutes and information;
- Reach out to the past Chair; and
- Petition all Districts to provide the *Committee* with a list of treatment facilities in their District along with a list of members willing and available for temporary sponsorship. This list to include name, phone number and zip code.

The *Committee* discussed the General Service Conference Agenda Item regarding the revision to the pamphlet Bridging the Gap. After a group conscience, the Treatment Facilities Committee voted in favor of the changes to the pamphlet which addresses linking new release inmates to temporary sponsors.

District Reports (submitted in writing):

District 1 Scott: The monthly meeting was held on Thurs 3/13 at 7:30PM at the Kiwanis Club in Hermosa Beach with 47 in attendance. Curt S did a Jeopardy Event presentation for the South Bay Roundup. We finished filling all the District positions except for 1 open DCM position, Dustin is our new District Archivist and Danielle is our Central Office Liaison. We had at least 13 members attend PRAASA – nearly half of them were there for the first time. On 3/29 Districts #1 and #3 are hosting a Pre-Conference workshop with our Delegate Cesar and Alternate Delegate Joe will share. The South Bay Roundup will be held May 23rd to 26th, Memorial Day Weekend.

District 2: On 3/3 at 7PM in Lakewood we had our District meeting with 22 in attendance. We held a meet and greet pizza party - we invited unrepresented groups and anyone interested in General Service. This resulted in a 75% increase compared to the previous month and we are still working to double this in the next 9 months. I attended the 4 Area Sharing Session - it was great.
