Concept 8 (Short Form) *The trustees are the principal planners and administrators of over-all policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.*

Continuing in the vein of Concepts 6 and 7, this Concept further defines the role of the General Service Board. Ever aware of the continuing danger to our Fellowship of the unchecked quest for money and authority, Bill W. writes in his essay on Concept 8, “**However, experience**

We arrived in San Antonio, Texas on the warm, steamy afternoon of Sunday, June 27th, after a two-day drive from our home in Costa Mesa. The weather report predicted the possibility that hurricane Alex, lurking about in the Gulf of Mexico, might drop a significant amount of rain on San Antonio by Tuesday and throughout the week. Jim and I have attended five previous International AA conventions, none of which had been affected by a hurricane that we could recall....

We arrived several days early to attend the Past Delegates' Reunion, which, on convention years, takes place a few days before the convention begins.

We strolled up the Riverwalk to the first lock. Meandering through the city, the Riverwalk affords tourists and locals an interlude of tranquil strolls, healthful exercise, and water taxi transportation and tour opportunities.... The afternoon temperature was only in the 80s...not so bad.

The presentations at the Past Delegates' Reunion were inspiring and moving...they included a panel entitled “Life After Rotation” with sharing from five past trustees and past delegates; “AA Around the World” by past delegates and trustees from Germany, Japan, Sweden, the United Kingdom, and South Africa; “GSO Service Highlights” moderated by a past GSO General Manager and sharing from four past GSO staff members.

Anonymity and the Internet (aka Digital Age)

I was thinking about this the other day and how anonymity online affects a lot of us in Alcoholics Anonymous. For me personally, this hits home. Many of my AA friends know I sell online advertising for a living. As part of my job I elect to be part of social networking sites such as Facebook and Twitter as some of my client's use

And lastly, and certainly a highlight, was excellent sharing from a past Class A Trustee and a past Delegate from California.

In addition to the convention itself and the Past Delegates' Reunion, we also attended the Past Trustees Banquet (I tagged along after Jim and am honored to be included in this wonderful group of dedicated and loving trusted servants) and the Delegates' Luncheon, where each of us join with other members of our own panel. At one point I went searching for the Panel 42 table to say hello to Jim. As I found 47 and then 43, I said sort of to anyone nearby, "It looks like I may be close to finding my husband." From one of the tables came the response, "Today may be your lucky day!"

People started pouring into town on Thursday and green-shirted volunteers could be spotted everywhere giving directions, offering help and smiles and support. It rained off and on, but the hurricane had dissipated and I didn't see any serious effect on the general good spirits of the convention.

Our GSO General Manager announced later in the weekend that there were over 52,000 of us who registered for the convention.... Bars all over town were deserted (unlike in some other cities where the bars have rallied and served coffee, sandwiches, and soft drinks with big "Welcome AA" signs)....but there were long lines outside ice cream parlors and pizza stands. People greeted each other with smiles and handshakes and hugs... many struggling to speak and understand a wide variety of languages.

I thought I saw my mother one afternoon, hurrying ahead of me in the crowd...and how I wish it could have been. My beautiful, intelligent and funny mother was an alcoholic...one who never found AA and never got sober. She died of an intentional overdose of drugs and alcohol in February of 1978 in her home where I found her body, kneeling over the coffee table with her empty coffee cup still wet with whiskey in her hand. She would, I believe, have loved AA, although she would have had trouble with the "God" thing, as have I...but I know that, as I have, she would have found that the phrase "god is love" has deep and profound resonance in AA.

Although I didn't see my mother (who would now be well over 100 years old) in person in San Antonio, I saw her in every single sober woman...and man, for that matter....

They say that 10% of the population of the United States, and maybe the world, are possibly alcoholics...and the World Health Organization has named alcoholism as the leading health problem in the world. We are part of a just, loving and significant social cause, as well as a personal, life-saving journey.

International Conventions remind me that there are deep and abiding common interests and common understandings that can transcend all the other "important" differences we squabble, argue, fight and kill over. How much is a resentment worth?

There is much to be done and we, in the Mid-Southern California Area 09, can do much, much more than we already are...I hope all who attended the International Convention are inspired, as I am, to focus our sights, projects, and programs on how we can better carry our message ("having [] a spiritual awakening as a result of these steps") to the alcoholics in our area who still suffer and drink.

It has been estimated, from our own surveys, that there are approximately 48,000 recovering alcoholics in our area. 10% of the population of seven million, is 700,000, less 48,000 of us, equals **652,000 alcoholics**. Do they all know about us? Where are they? How can we reach them? What are we doing to let them know who we are and what our program is? Are we reaching enough professionals? Seniors? Remote communities? People with special needs? Those who speak other languages? Different cultural backgrounds?

Alcoholism is a chronic, progressive, fatal disease...each one of the people I saw on the streets of San Antonio last weekend is a walking miracle... I am so grateful to be part of this fellowship and to be serving with you, here in Mid-Southern California Area 09!

dating from our earliest days strongly suggests that future Trustees and service workers, in the supposed interests of accounting simplicity, tax savings, and hoped-for efficiency, will be periodically tempted to go in for concentrations and consolidations of one kind or another. Should this be again attempted, we know that the risk of making an administrative shambles out of the total operation will be great indeed". Throughout the essay on Concept 8 Bill reinforces the idea that the best style of management for a business is, well, a type of business management. This Concept grants oversight of the two corporations wholly owned by A.A. – Alcoholics Anonymous World Services, (AAWS) and the Grapevine, Inc. directly to the General Service Board. It also instructs that the Board of Trustees should not and cannot be directly involved in the daily, weekly and monthly management of these two corporations. They are granted the power to elect the Directors of the corporations, (subject to approval by the General Service Conference), after which, the Trustees are instructed to "plan, manage and execute" their own duties and leave the management of the two corporations to the responsible boards.

As much as any other principle, this Concept has been directly responsible for allowing the entities of A.A. that are involved in business matters to manage those business affairs without constant second-guessing, (but, as you would expect, this still goes on, somewhat) and allows the Groups to tend to the matters of 12th Step work. This is where the material is truly separated from the spiritual. Now the real reason this Concept works is found in the next Concept – Concept 9. I'll give you a hint – Concept 9 deals with Leadership.

these sites to promote their businesses. For social media networking, I have two Facebook accounts (one for work, one for personal). Reason, I don't want work acquaintances to know about my personal life and try very diligently to protect my anonymity. This isn't always easy.

I know a lot of us in AA are members of Facebook. I personally have 161 friends on my Facebook account that are members of AA and only one of them is on Twitter that I'm aware of. I'm not bragging that I have a lot of friends on Facebook but I have a lot to be concerned about as to how to protect my personal anonymity. Tradition 11 states that "Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films." Perhaps this should be extended to digital too, I don't know, that is for AA to decide.

So what do we do to protect our own personal anonymity online? I will share a bit of what I do to try to protect my anonymity. With potential employers searching social networking sites prior to employing them we should take this very seriously. Did you know that if you Google search your name that all of your groups that you are a part of on Facebook or fans of have the potential to come up? This has happened to me. What if you were a Fan of Bill W. or Alcoholics Anonymous? Or even the group that has Serenity Gifts? To me, this being made available for all to see along with your first and last name is scary to me. We are not always given the opportunity to defend ourselves, many who possibly read this will jump to judgment and never ask us personally questions about their findings.

I make sure my privacy settings are set accordingly on Facebook. I try not to post anything AA related on my status updates. I never join any type of group or page that has anything to do with AA, it doesn't mean I'm not a proud member, just don't want potential clients, future employers, etc. to know this about me. Instead they will find out that I like Green Day, Coldplay, 80s music, Farmville, etc. Also, I don't publicly post pictures or videos of others without their consent.. How many times have we attended AA birthday parties, events, or even AA related round ups or conventions and posted pictures of people, tagged them on Facebook and posted. Did you get their consent?

Another thing I will do is set my privacy settings and hide those friends of mine that post A LOT of information about AA on their status updates. For example, one of my friends posts first and last names of people that are speaking at AA meetings. They don't post that it is an AA meeting but this leaves room for questions. Another one talks about meetings continuously and sobriety. I have had some of my non AA friends comment and ask "what is a friend of Bill W, etc. I will usually email these people personally and explain. I will also email the person that posts on my wall something related to AA and say that I am anonymous to several friends on Facebook and please do not post anything publicly regarding AA on my wall.

Another thing that I do as Secretary of Mid Southern California Area 9 with regards to email distribution. I will bcc everyone that I am forwarding a mass email to. All too often we forget that a lot of us do not want our email to show up on forwarded emails. This opens up your email address for spam and potential viruses. I am extremely diligent on this for Area 9 business and try to do this with my personal emails too such as forwarding jokes, prayer requests, etc.

Finally, what about You Tube? You Tube is the 2nd largest search engine next to Google. Just search Alcoholics Anonymous on You Tube. You will find a series of talks from Chuck C. at UCLA, people openly speaking about AA etc. Don't get me wrong, You Tube is a great venue for PSA's and AA.org has an account "aapublicinfo". Unfortunately, these PSA's have only been viewed 7,314 times. Then again it is "attraction" rather than "promotion".

I think a lot more discussion and loving conversation needs to be brought to the forefront on this and am hopeful that Area 9 will come up with some brilliant ideas on how we can combat this growing concern in the AA community. By all means, please feel free to share this with your groups if you think it will be helpful or ask me any questions. I had a lot of fun writing this article and hope some of you find it useful.

Our A.A. experience has taught us that: Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we might otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. Twelfth Step work is never to be paid for.

First ASC after each Assembly: *The ASC members will present proposals, but no vote will be taken on them.*

Second ASC after each Assembly: *ASC members will vote on which proposals to put on the agenda for the next Assembly (for GSRs to vote on).*

What's the Purpose of an ASC?


1. Identifying, defining, and discussing Area, District and Group problems and issues.
