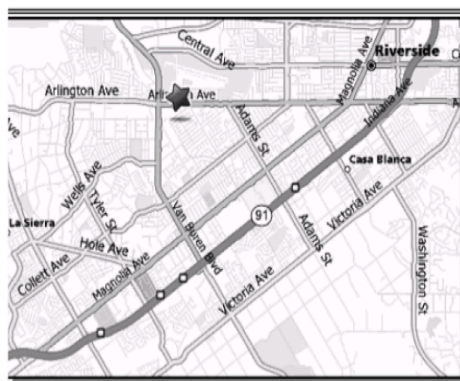

## LITERATURE WORKSHOP WAS A SUCCESS!

The MSCA 09 Panel 62 Literature Committee hosted a Literature workshop on May 5<sup>th</sup> at the MSCA 09 Archives Repository in Riverside.

The Workshop started with a

demonstration of 3 different types of literature displays that are typical for AA meetings: a very large wooden display, used by the MSCA 09 Literature Committee at area events; a wire rack with book extensions; and a video camera recorder case used to hold literature.

Volunteers with less than 6 months of sobriety were asked to stand in front of the display that they felt most attracted to and they all stood in front of the wire rack. The audience was asked what was

been an integral part of the Fellowship since its beginnings. In fact, A.A. might never have gotten off the ground without the help of a myriad of caring nonalcoholic professionals—doctors, members of the clergy, educators, law enforcement officials—who came to recognize early on the effectiveness that A.A. was demonstrating in helping alcoholics to recover.

Critical in this relationship between A.A. and its nonalcoholic friends, a relationship forged in the pursuit of common goals—how to best help the

still-suffering alcoholic and provide an ongoing means for recovery from the effects of alcoholism—is the spirit of collaboration.

Speaking about A.A. in a presentation to the New York City Medical Society on Alcoholism in 1958, the Fellowship's cofounder, Bill W., acknowledged the fundamental similarities between A.A. and the fields of medicine and religion, and expressed how this spirit of collaboration has paved the way for countless alcoholics to recover.

"Certainly nobody invented Alcoholics Anonymous. A.A. is a synthesis of principles and attitudes, which came to us from medicine and religion. We alcoholics have simply streamlined those forces, adapting them to our special use in a society where they can work effectively. Our contribution was but the missing link in a chain of recovery which is now so significant and of such promise for the future."

Elucidating further in a 1958 article, available today under the title,

### TRADITION VI (Long Form)

Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

### CONCEPT VI (Long Form)

On behalf of A.A. as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the Conference also recognizes that the chief initiative and the active responsibility in most of these matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous.

### TRADITION VII (Long Form)

The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then, too, we view with much concern those A.A. treas-

## MAY 2012 AREA ASSEMBLY NOTES

Following early committee meetings, the May Assembly was called to order at 10:20 a.m. by Chair, Cesar F., with the Serenity Prayer. Readings were followed by introductions of Past Delegates, new GSRs, DCMs, and DCMCs. The minutes of the January Assembly were approved as submitted by Secretary, Jesus O.

### Officers/Directors' Reports:

Alternate Delegate, Sharon K., reported that she had attended several workshops and noted that there were over 250 people at the Pre-Conference Workshop, which may be a record attendance for an area event in recent years. She especially remarked on the Literature Workshop, hosted by the Literature Committee at the Archive Repository and how informative and well-organized it was. She reiterated that she is always available (work permitting) to speak at any group or district.

Registrar, Raul C., reported that he is working on new group registration updates and welcomes any current information from groups in the area.

Secretary, Jesus O., thanked everyone who worked so hard on the Conference Agenda item summaries; he expressed his gratitude for the opportunity to serve. He has been visiting groups and district meetings and also attended the recent H&I convention.

Treasurer, Annie D., gave an update on the status of the area financial status. [a summary is on page one of this newsletter].

Chair, Cesar F., reported that he has been busy conducting the business meetings of the area, posting agendas, and presiding at the meetings. He is working on the 2013 calendar and should have it ready for presentation at the June ASC. He encourages everyone to visit the area Archive Repository as it is, really, more interesting than you may imagine.

Delegate, Jeryl T., commented on the value of the Pre-conference workshop for him and thanked everyone for their participation. He also mentioned that a contingent of people from our area will be driving to Colorado for a La Vina Workshop and expressed his excitement about the enthusiasm in our Spanish-speaking community. He also expressed gratitude to all of those participating in the "Think Tank" meetings.

FORO report: The upcoming Area Foro will be held in Laguna Woods [see flyer] ***and no one will be allowed through the gate without a flyer properly filled out.*** This was explained fully in English and in Spanish. Copies of the flyers were available at the assembly and will be available in the newsletter and on our website. If a driver does not have a flyer filled out, there will be AA members available outside the gate with flyers on the spot. However, it will greatly improve traffic holdups if every driver has a flyer already filled out.

### NEW BUSINESS

1. **Audit Committee Report:** Based on the following four points, the Audit Ad Hoc Committee recommended that the Mid-Southern California Area 09 Assembly accept the Audit Report for the year ending December 31, 2011.

a) Mid-Southern California Area funds were in the bank as stated in the Treasurer's end of year report.

b) Financial statements for the fiscal year 2011 were comparable to the 2010 financial statements and the cash balance as shown on the bank statements (checking, Archives, and savings) agrees with the Quicken checking and savings registers.

c) The treasurer maintained clear, accurate, and traceable records.

*“Let’s Be Friendly with Our Friends,”* Bill notes: “Today, the vast majority of us welcome any new light that can be thrown on the alcoholic’s mysterious and baffling malady. We don’t care too much whether new and valuable knowledge issues from the test tube, a psychiatrist’s couch, or from revealing social studies. We are glad of any kind of education that accurately informs the public and changes its age-old attitude toward the drunk. More and more, we regard all who labor in the total field of alcoholism as our companions on a march from darkness into light. We see that we can accomplish together what we could never accomplish in separation and in rivalry.”

This spirit of cooperation remains a cornerstone in the ongoing relationship between A.A. and the professional world—those who work with alcoholics in correctional facilities, treatment facilities, drug courts, and such.

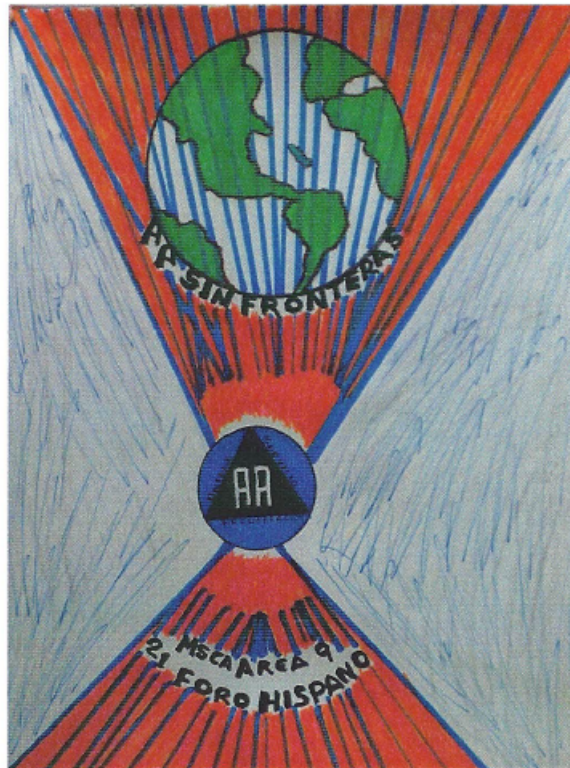
