The motion to "split the area" was quickly withdrawn when the group offering the motion realized that in order to create a new Delegate Area, the General Service Conference must assess and determine whether it is in the best interest of AA as a whole to create a new delegate area.

Recognizing that the observations and motivation for the suggestion were not only valid, but extremely important, the Panel 60 Board members recommended the formation of a committee, or THINK TANK, to identify and describe things that need improvement or, perhaps, reorganization. They are looking closely at those procedures and policies that have had good success, as well as the obvious such as lack of participation by a majority of groups in area affairs.

GROUP DISCUSSION TOPICS

In preparation for the Pre-Conference Workshop, following are some questions for discussion with group and district members relating to the Conference Agenda items. Background material will be available at each round table at the workshop.

1. Some of our literature has the phrase, "Anyone may attend an open AA meeting." Does your group think it would be helpful to change that phrase to read "Non-alcoholics may attend open AA meetings as observers."? (Corrections)
2. In 2010, the Trustees Literature Committee discussed updating the Armed Service pamphlet to include a more recent and wider variety of stories and to add the subtitle "*None Left Behind*" to the pamphlet. Does your group have concerns about updating this pamphlet? How do they feel about the proposed subtitle?
3. The cost for the Annual General Service Conference is \$5,800 per delegate. The Delegate areas are now asked to contribute \$1,200 each. The difference is paid for by additional contributions by some areas and from the General Fund that is supplied by group contributions and literature sales. Does your group believe that the suggested Area contribution, in the spirit of self-support, should be raised?
4. Does your group believe that the Spanish-language magazine, *La Vina*, should continue to be published by the Grapevine and supported by the AAWS general fund as a service to AA?
5. A suggestion has been made to combine the responsibilities of the

CONCEPT III

“As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional

“Right of Decision.”

CONCEPT IV

“Throughout our Conference structure, we ought to maintain at all responsible levels a traditional “Right of Participation,” taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharge.”

With the exception of certain specific directions in the Conference Charter “every trusted servant and every A.A. entity---at all levels of service---has the right ‘to decide...how they will interpret and apply their own authority and responsibility to each particular problem or situation as it arises.’ That is, they can ‘decide which problems

They will dispose of themselves and upon which matters they will report, consult, or ask specific directions.' This is 'the essence of ***The Right of Decision.***'

"The principle of "***Right of Participation***" is built into the ... Conference through the Conference Charter. Voting members include not only delegates, but also trustees, and the directors and staff members of A.A. World Services (i.e. GSO) and the A.A. Grapevine.

"In the same way, the boards of these two operating entities include as voting members not only trustees, but also nontrustee directors and paid administrators and staff members.

"..."There are no "superiors," no "inferiors," and no "advisers." New trustees ... and new directors of the AAWS and Grapevine boards are sometimes surprised to see paid executives, staff members and outside accountants attending the board meetings. They are invited because of A.A.'s 'Right of Participation.' Thus the trustees and directors 'are put into direct communication with these workers, who...feel wanted and needed. Although they do not vote, these workers may freely participate.'

TRADITION III (Long Form)

"Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation."

TRADITION IV (Long Form)

"With respect to its own affairs, each AA group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group,

Following the Delegate's Sharing session, the GSR School meeting and the Finance Committee meeting, all other standing committees met and made plans for the their respective projects. After delicious lunch, the committee meeting was called to order at 12:20 by Area Chair, Cesar F. Panel 62 **Delegate**, Jeryl T., reported that he had received the agenda for his Conference Committee (Report and Charter) and expects to receive the rest of the background material and agenda on Feb. 15th. Based on that information the **Conference Agenda Summary committee** has been appointed and will have its first meeting on Sunday, Feb. 19th. **Alternate Delegate**, Sharon K., was unable to attend due to illness. **Registrar**, Raul C., pointed out that it is important to remember that new groups cannot be listed with GSO without a GSR or other primary contact person. **Secretary**, Jesse O., asked that everyone review the Area roster and give changes to him as soon as possible as well as new listings for his eBlast list of ASC members. **Treasurer**, Annie D., appreciates the fact that so many contribution checks have Group Service numbers. She also reminded committee chairs to become familiar with their budgets so that in their enthusiasm they don't overspend and if they have plans for something special or unusual, to contact her so that arrangements may be able to be made to accommodate the plan. She also gave a short update on the Area bank account balances. **Chairperson**, Cesar F., announced that only the actual meeting portion of the ASC's and Area Assemblies will have professional simultaneous Spanish translation from this meeting forward; unpaid volunteers will provide any translation at committee meetings or for the delegate's sharing. He also mentioned that there are several groups who plan to rent vans to drive to the Pacific Region AA Service Assembly in Bellevue, Washington, and that there are a few seats still available.

Old Business: Discussion of the motion to bring the draft pamphlet on "**Safety in A.A.**" to the Area Assembly for consideration had been tabled at the last ASC for this meeting. After lengthy, spirited discussion, Michael M. withdrew the motion and a new motion was introduced to form a study group to review the feasibility of the pamphlet. That motion was "set aside" for an indefinite period of time by a majority vote.

Hospitals & Institutions

Paul was our next guest speaker from H&I and told us how he got involved. The H & I Committee is dedicated to providing AA meetings and literature to those hospitals and institutions that request support from Alcoholics Anonymous. They carry the message to treatment and outpatient centers. H&I serve as a link between the treatment setting and the outside AA group. They carry the message behind the walls of institutions and smooth the way from the facility to the larger AA community upon release. H & I, as an integral part of the alcoholic recovery functions of AA, and is there to reach out to hospitals and institutions that support alcoholic recovery.

WHAT ABOUT PAST DELEGATES?

MSCA's roots prior to 1959 were in Area 05 where the Past Delegate was rotated automatically into the Area Chair position. The new area 09 decided to elect a chair instead, as we still do.

The area valued the experience of its past delegates and one way they made use of past delegates' experience was as newsletter editor, and until 1992 it was common for the immediate past delegate to be editor of the area newsletter, and was revived in 2010. MSCA also asked them to serve in various other capacities. For instance in 1984 the only "committee" **not** chaired by a past delegate was Grapevine.

In 1986 MSCA formed its first Finance Committee, and Archives Committee, each of which was chaired by a past delegate. In 1988 the Convention Liaison Committee was formed and was chaired by a past delegate.

Currently in MSCA, past delegates are members of the Area Service Committee and Area Assembly, with lifetime voice and vote. MSCA also invites past delegates who served in other areas, but currently reside in MSCA, to be voting members. They are not eligible to serve as area officers, but are currently welcome to serve on and/or chair various committees or sub-committees.

Some areas ask their past delegates to serve only as advisors, some invite participation. Is it time to revisit this in our area?

Regional committee, or individual should ever take any action that might greatly affect AA as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
