Guidelines are being drafted for the committee and for each subcommittee, which will be incorporated into one document. The proposed draft will be submitted to the Area for review, recommendations and approval as soon as possible.

## Delegate's Corner.. "But trusted servants"

Within our groups (and of course our Area) there is no such thing as individual authority. No one member "directs" or "controls" the actions of the other members of the group (or this Area).

*Tradition 2. (Long Form)*

*For our group purpose there is but one ultimate authority — a loving God as He may express Himself in our group conscience.*

*Tradition 2. (Short form)*

*For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern*

Group decisions are just that, group decisions. After a discussion of all aspects of a given situation, including the minority opinion, the group votes on the issue and an agreement is reached with the majority vote. This vote is called a "group conscience."

Each group is a fellowship of equals. No matter what an individual member's background, education, or professional expertise, or amount of time sober, no member has authority "over" the Group, District or Area. In this way, the fellowship reaches out to all who would seek its comfort and provides the atmosphere of a sense of "belonging" to all members.

But: there are leaders...

This tradition has been misquoted many times as, "we have no leaders." But it clearly states that we do have leaders, they just have no authority over the rest of us. Whether they are the group's representative to the District, or the Area, or even the Delegate, they have been entrusted with the responsibility to serve those that have elected them, not make decisions for them.

We clearly have other "leaders" also. There are those, who by sharing their wisdom and strength in the meetings, who are quietly recognized by us as "spiritual leaders." There are those members, who are so well grounded in the principles and traditions of the program, the group turns to them when questions come

## Newsletter Subcommittee Chair Needed

Printing, sorting & distributing the Newsletter is pretty much a one person job; though the more people you have helping you, the easier it can be. Layout can be done by a Newsletter Editor (the Newsletter Committee Guidelines called for a Newsletter Editor). Gathering articles and information can be done by everyone on the Newsletter Committee, although it is up to the Newsletter Chair as to what makes it into the final copy.

The first part is **Content**: You and the rest of your committee can ask people to submit articles to the newsletter – some will even submit monthly like the previous Delegate's Corner or articles on the Concepts or Traditions. I have found that the Area Officers will always submit articles if requested to do so. The Committee Chairs are also eager to share what their Committees are up to. But it is up to the discretion of the Newsletter Chair for what is accepted and what is rejected – and you can always run them by other members of the Area Communications Committee if you are unsure.

The next part is **Editing & Layout**: The Newsletter Editor uses a template which includes the header and guidelines, so that the newsletter looks fairly similar from one issue to the next. Use of the template also makes it easy to generate each newsletter, because once the template is used, it is easy to re-use for the next issues. Editing consists of using standard software spell checks and grammar checks, and correcting any errors found. Once the editor has collected, edited and laid out the newsletter, it is reviewed by the Newsletter Chair (and any other proofreaders you might select) for correctness, consistency with AA principles (e.g. no anonymity breaks), clarity, etc. Only the Newsletter Chair can give the final okay to go to print.

Last is **Printing & Distribution**: Take the finished product to a printer and have them printed out – we know how many copies by keeping a list of who needs what. Then comes the fun part of separating them for each Receiver (District, Central Office, Clubs & Other Committees) & bagging them for taking to the monthly Area Assembly or ASC. It usually takes me about 3 hours to do it, but that's because I watch movies while I do – otherwise, it probably takes an hour.

Being the Newsletter Chair is a rewarding experience & I didn't drink the entire time I had the commitment.

up involving possible violations of those principles and traditions. These too are leaders, but they also do not govern.

This brings to mind the bleeding deacons and elder statesmen that are referred to in our 12 & 12.

I have heard many in my group and Area called this, but it wasn't until just recently I came to understand how to identify them. (Or "myself" when I get carried away thinking I'm all that. (definition from my trusty well thumbed 1947 Webster's dictionary))

### Bleeding deacon [n]

A person who believes himself indispensable to a group,

esp. a person who becomes so over-involved in a group's internal management, policies, or politics as to lose sight of its larger goals; (hence) a person with a negative, moralizing character, who acts like the sole source of wisdom.

### Elder Statesmen [n.]

A person, advanced in years and experience, especially a politician or former politician, who is respected for his or her wisdom and whose advice is still valued and unofficially sought

These are both leaders aren't they? One type leads through condescending intimidation using his experience as the only rule of example. Not that there is any malicious intent to bring down the whole structure of the group, (District or Area) they just can not see how others could be so wrong and not see how they are so right. And you know what... they just may be right. I just don't believe that their being right makes others wrong.

This is why I adore the literature that is available to all of us, we are able to find something that we have no experience with, look into our literature and develop our own knowledge allowing us go out into the world and make our own experiences. And if it is your experience... how can that be wrong?

*Here are three questions taken from the "A.A. Grapevine's Twelve Traditions Checklist" that I would like you to reflect on about Tradition Two.*

1. Do I criticize or do I trust and support my group officers, AA committees, and office workers? Newcomers? Old-timers?
2. Do I have to save face in group discussion, or can I yield in good spirit to the group conscience and work cheerfully along with it?
3. In group discussions, do I sound off about matters on which I have no experience and little knowledge?





North Town Hall building\* of the Sun City Civic Association


